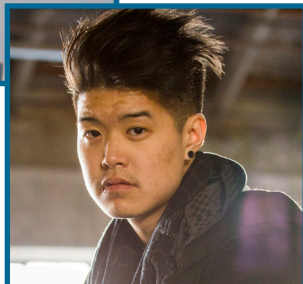
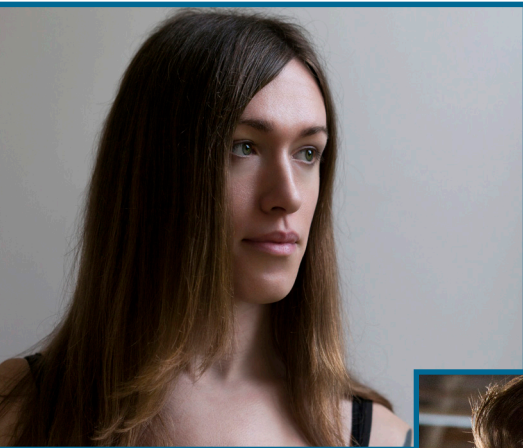

## NAME AND GENDER MARKER CHANGES

- Are you a transgender or nonbinary sexual assault survivor who needs help getting a court order to change your name and/or gender marker on identity documents?
- Do you want help changing your gender and/or name on your birth certificate, driver's license, school transcripts, passport, immigration documents, or other IDs?
- Do you need help paying court fees or covering other expenses related to obtaining updated ID documents?

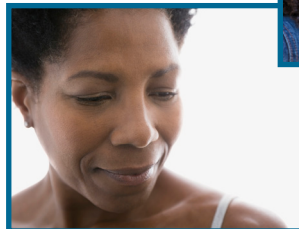


## EDUCATION
