

## Lane Community College Tuition Waiver for Part-time Employees or Other Qualifying Category

### Eligibility Criteria

<i>Employees registering for credit classes need to apply for admissions at <a href="http://www.lanec.edu">www.lanec.edu</a>.</i>	
<b>Part-time credit faculty</b>	Those who qualify for the faculty bargaining unit* are eligible for one tuition-free class during the term they teach <u>or</u> during one of the subsequent 3 terms. Such waivers may be accrued but must be used within each fiscal year cycle (July-June annually) beginning with summer term and ending with spring term each year. All waivers earned or accrued in winter or spring terms must be used by the immediate following summer term and shall not be accrued or carried forward into the next academic year. Employees applying to Human Resources by June 30, annually, shall be granted an exception that allows accrued waivers to be used beyond the fiscal year.
<b>Hourly classified employees (C-3)</b>	Those who qualify for the bargaining unit and have worked less than 700 hours in the past 12 months are eligible for one tuition-free class during the term they are working. Hourly classified employees (C-3) that have worked more than 700 hours in the past 12 months are eligible for unlimited tuition waivers.
<b>Goshen Fire Department Volunteers</b>	Are eligible for tuition-free classes each term for certain qualifying categories of classes. Eligible classes are limited to the following: EMT classes and the Fitness Center. Eligibility for fitness center classes include enrollment in the transportation fee exempt section.
<b>College Now High School Teachers</b>	Are eligible for one tuition-free class per academic year.

\*Part-time credit faculty who teach more than .20 FTE in a single term are eligible for the faculty bargaining unit and the benefits defined therein.

### Not Eligible

Continuing Education instructors (non-credit) and all part-time credit instructors with workloads below the bargaining unit eligibility threshold\* are **not eligible** for a tuition waiver. Classified non-bargaining unit employees are **not eligible** for tuition waivers. Volunteers, Learn & Earn, and Workstudy students are **not eligible** for tuition waivers.
