

Dynamics of Sexual Harassment on College Campuses


- *1 in 5 women, 1 in 16 men, and 21% of gender non conforming* students are sexually assaulted in college in the US
- 13% of women report being stalked while on campus
- Cases are underreported
 - Only 20% of female victims report to law enforcement
 - Overall, about 3 out of 4 cases go unreported

Dynamics of Sexual Harassment on College Campuses

- **80-90% of sexual assaults involve students who know each other**
 - Friends
 - Team Mates
 - Class Mates
 - Co-Workers

What is Title IX?

Title IX of the Education Amendments of 1972 protects people from discrimination based on sex in education programs or activities that receive Federal financial assistance (this includes colleges and universities).

- Used to be focused on women's athletics, now pertains to sexual harassment cases in addition.

- **Retaliation**

Key Points

- Not just about athletics
- All students have a right to access an education free of violence and discrimination
- College has to have a procedure for reports
- College has to take immediate action
- Retaliation prohibited
- All parties will get due process

What Can it Look Like?

- Unwanted touching (does not have to be sexual parts)
- ANY non-consensual sexual activity
- Physical and violent assaults
- Domestic/interpersonal violence
- Hostile environments
- Digital harassment
- ***Even when there are no witnesses***





What is Consent?

What is Consent?

- The voluntary, informed, uncoerced agreement through words and actions freely given, which a reasonable person would interpret as willingness to participate in mutually agreed-upon sexual acts.
- Happens when each partner willingly and affirmatively chooses to participate.



What Consent is Not

- Consent to one act does not constitute consent to another act.
- Consent on a prior occasion does not constitute consent on an other occasion.
- The existence of a current/prior relationship does not constitute consent.
- Can be withdrawn or modified at any time.
- Is not implicit in a person's manner of dress.
- Accepting a meal, gift, or date does not imply consent.
- Silence, passivity, or lack of resistance does not constitute consent.
- Initiation by someone who a reasonable person knows or should have known to be deemed incapacitated is not consent.

Athlete's Responsibility


- If you see inappropriate behavior, say something.
- Report to Title IX and/or coaching staff.
- Don't participate in inappropriate behavior.
- Pay attention to how you interact with others.



Title IX Process at LCC

If a Title IX concern is reported:

- Person immediately given supports and resources
- Person can file a formal complaint
- **If rises to federal:** investigation, live hearing, final findings, appeal
- **If rises to state:** investigation, final findings, appeal



Sexual Respect at Lane

Lane Community College does not tolerate sex or gender discrimination, including sexual misconduct such as sexual harassment and sexual assault, stalking, and intimate partner violence. These behaviors are harmful to the well-being of our community members, the learning/working environment, and collegial relationships among our students, faculty, and staff. All forms of prohibited conduct under this procedure are regarded as serious College offenses, and violations will result in discipline, including the possibility of separation from the College. State and federal laws also address conduct that may meet the College's definitions of prohibited conduct, and criminal prosecution may take place independently of any disciplinary action instituted by the College.

What is Sexual Misconduct?

Sexual misconduct offenses include but are not limited to:

- Sexual harassment;
- Non-consensual sexual contact (or attempts to commit same);
- Non-consensual sexual intercourse (or attempts to commit same);
- Domestic violence/dating violence/intimate partner violence;
- Sexual exploitation.

Scenario
