

# Moodle Orientation Navigation Tutorial

Log into your LCC Moodle account and select the Center for Accessible Resources Orientation course.



On the course homepage, there are four sections, each with multiple lessons. Notice that they are all marked restricted except for the very first lesson: "What is CAR?" You must complete each lesson before you can move on to the next. Once you have completed all lessons in a section, you will be able to move onto the next section.
