LANE NURSING

Lane offers a fully accredited Nursing Program through the Oregon State Board of Nursing. Lane RN Program graduates have a history of passing the NCLEX RN exam with a 94% pass rate averaged over the last fifteen years. The Nursing program is both exciting and challenging; offering graduates the opportunities for employment in a variety of settings and for a lifelong career of personal fulfillment and societal benefit. Nursing is a demanding field and admission to nursing schools is a very competitive process.

THE OCNE CONSORTIUM

Lane has joined other community college programs and Oregon Health & Science University (OHSU) in a unified approach to nursing education. This coalition of statewide nursing educators and programs is known as the Oregon Consortium for Nursing Education (OCNE). All consortium nursing programs have the same prerequisites and comparable application processes for students. Go to www.ocne.org to see a list of schools and more information on OCNE. 2014 FORMS SUBMISSION AND PAYMENT PHASE:

- 1. Admission to Lane
 - If you are not currently a Lane credit student, complete <u>Lane's college credit admission process</u> and obtain a student "L" number. Make sure to complete all "<u>Steps to Enroll in Credit Classes</u>" including a prior college clearance if you are new to Lane (see Steps to Enroll for more information).
- 2. The Forms Submission and Payment Phase has two parts an On-line Application & Payment, and submission of fillable Form 1 (Conditions for Application Checklist) and Form 2 (Point Petition Sheet). You are not considered an applicant to the program until you meet all application requirements.
 - A. Instructions for the On-line Application and Payment follow the forms pages. This application will include a \$50 non-refundable application fee, therefore do not initiate until you are sure you will have the prerequisites and requirements met, submit official sealed Transcripts (if needed) and are ready to submit Forms 1 and 2.

ENSURE YOU WILL RECEIVE – Your invitation to the INTERVIEW PHASE of the application process or your notification of non-acceptance.

Notification of your status for the Interview Phase will arrive by E-mail and/or myLane portal.

- VERY IMPORTANT! Set your "spam filter" system to accept mail addresses containing @lanecc.edu or your notification may be spammed! Do this even if you are currently receiving e-mails from Lane.
- Be sure you will be available to be interviewed during the dates provided on page 1.

PREREQUISITE COMPETENCIES: Must receive a GPA of 3.00 or higher on all prerequisites listed on Form 2. All coursework must appear on a Lane Transcript and/or submitted official transcripts from other schools.

- 45 credits of specified prerequisite courses (listed below items 1-8 plus enough credits from 9 to meet credit total) must be earned prior to the start of the first term of the nursing program.
- All courses letter grade C or higher (C- or lower not accepted); the only exception is MTH 95.
- 30 credits (of the 45 prerequisite credits) must be completed and appear on a transcript by the application deadline. The 30 credits must include Bl231 and Math Proficiency (see below) and courses from Items 1-7.
 Applicants must have 30 credits from Section 1 to meet the minimum criteria to apply. Credits from Math courses with a pass grade may not be used to meet the 30 credit minimum to apply.
- Any courses completed that meet the criteria as OCNE prerequisites must be included on Petition for Points page, up to 47 credits. Applicants may repeat courses in order to raise the GPA. The most recent grade will be used for GPA calculation whether it is higher or lower than previous grades.
- Applicants with courses taken at other colleges please refer to the Topic 4: Transferring Credits.
- 1. Anatomy & Physiology I, II, III: (12 credits) BI 231, BI 232, BI 233 BI 231 is required to apply. BI 232 and BI 233 are required to be completed to enroll in the Fall for accepted students. BI 112 and CH 112 are prerequisites to BI 231 at Lane. These 6 credits may be used as approved electives in Section 2. If course(s) not taken at Lane use the Lane Transfer Tool or request a course equivalency from the Science department. If all three AP courses are more than 7 years old BI 233 needs to be completed Fall 2007 or later. UO/OSU students email MursingProgram@lanecc.edu Please list name of institution, term/year courses completed and course numbers as indicated on your transcript.
- 2. Math Proficiency: Choice of MTH 095 Intermediate Algebra or higher or one of the following options: If you have completed Math 095 or higher with a pass grade or options (a-c) below you will be required to submit suporting documentation and credits obtained will not count toward 30 credit minimum required to apply from Section 1 courses.
 - a) Lane Credit by Exam for MTH 095 Intermediate Algebra or higher
 - b) AP (Calculus), or CLEP (College Algebra, or any Calculus or Statistics)
 - c) IB (Mathematics, or Math Studies, or Further Mathematics or Statistics)
 - d) Graded ourse considered equivalent to MTH 095 or higher from accredited colleges/universities.

3. English Composition Courses WR 121 and WR 122 (6 to 8 credits) Applicants with a prior Bachelor's degree from a U.S. regionally accredited institution may waive this requirement. Students who have completed a U.S. Bachelor's degree and wish to waive the WR 121 & 122 requirement will need to complete additional approved electives to fulfill the 30 course credits required to apply to the program. Additional credits must meet the approved elective criteria –see item 8 below. List Approved Elective Item 8 courses that meet criteria in Section 1 as directed.

For applicants without a prior Bachelors who have taken college level freshman writing courses not listed as "WR 121" or "WR 122" use the <u>Lane Transfer Tool</u> or request a course equivalency from Lane's Language, <u>Literature & Communication Division</u>, Center Building 4th floor.

- 4. Nutrition FN 225 Nutrition (3 or 4 credits) or FN 240 Nutrition and Metabolism. If course not taken at Lane use the Lane Transfer Tool or request a course equivalency from the Health Professions division.
- 5. Human Development (3 credits) Lifespan Development
 The course must cover the developmental process of human life covering the full life span, (not just Child Development).
 - Options at Lane include: PSY 215; or HDFS 226 + PSY 236; or PSY 235 + PSY 236.
 - At Lane, the prerequisite is PSY 201 which can be used as social science credits.

 If course(s) not taken at Lane use the <u>Lane Transfer Tool</u> or request a course equivalency from the <u>Social Science department</u>.
- 6. Human Relations course (3 credits) See <u>Lane Catalog Associate of Applied Science Human Relations</u> requirement. See course list option. If course not taken at Lane use the <u>Lane Transfer Tool</u> or request a course equivalency from the <u>Counseling Department</u> or the instructional department that teaches the course.
- 7. Social Science course (3 credits). See Lane Catalog <u>Associate of Applied Science Social Science or Human Relations</u> requirement. See course subject options. If, course meets the subject criteria and is from an accredited institution numbered 100 level or higher or considered freshman through senior level then no further steps are required.
- 8. Approved Electives to total of 45 to 47 credits. See Lane Catalog <u>Associate of Applied Science Discipline Studies</u> course subject options listed under Arts/Letters (excluding studio art and performance arts), Theater Arts courses do meet criteria; Human Relations/Social Science; Science/Math/Computer Science. If, course(s) meets the subject criteria and are from an accredited institution numbered 100 level or higher or considered freshman through senior level then no further steps are required. CIS courses do not meet criteria. No more than two courses in one subject can be listed in Section 2 of Form 2 (e.g. ENG 104,105 and 106) 106 could not be listed.
- 9. Basic Computer Competency Success in a nursing program requires that students be computer literate, including at least word processing, use of spreadsheets, and web searches. Students without computer experience are expected to seek out opportunities for remediation in this competency prior to entering the nursing program. Check this link to assess your own computer literacy skills.
- 10. Plan to complete remaining non-NRS courses. <u>Biology with Genetics</u> and BI 234 Microbiology need to be completed by the end of Fall term prior to Winter term entry for first year students. Students without a Bachelor's degree who took WR 121 or WR 122 prior to Summer term 2010 need to complete WR 123 or 227 by the end of Winter term prior to Spring term entry in the first year.

TRANSCRIPTS

Submit Transcripts (if required) to Enrollment Services. All courses used for points must be recorded on your transcript.

- Do not submit transcripts from Lane Community College to Enrollment Services or the HP Application Center.
- <u>Sealed, official</u>, transcripts from schools other than Lane must be received (see address below) prior to the date Forms 1 and 2 are emailed to HPApplicationCenter@lanecc.edu

TRANSFER CREDITS, COURSE EQUIVALENCIES

Courses taken at other colleges may be eligible for use in the application process. Use the following steps and make sure to consult with a program advisor/counselor.

DO NOT DELAY. It is <u>your responsibility</u> to initiate the process early and make sure it has been completed by the application deadline.

IMPORTANT. Equivalencies must meet both <u>Core Program</u> and <u>AAS degree</u> requirements. See program advisor for <u>program requirements</u>.

- 1. For colleges other than Lane, submit an official, sealed transcript to Enrollment Services. College transcripts received by Lane's Enrollment Services may be verified in *myLane*. Select "myEnrollment" and then "Prior College Info."
- 2. Go to the Enrollment Services website Lane Transfer Tool.
- 3. Review "General Information for Transferring Credits."
- 4. Select "Look up Transferable Credits" to check on transferable classes for items 1-6 above. If your course(s) are listed as equivalent to course numbers and titles as listed above no further action is needed.
- 5. If the college/course is not shown see instructions provided above in items 1-9 (pages 2-3).
- If you obtain course equivalencies or substitutions request copy of the approval in-person or by email.
- Course equivalencies must be approved and received in Enrollment Services by your date of application.

Courses from Non-accredited colleges will not be considered in the initial evaluation of your application nor can they be considered toward any degree requirements. Email NursingProgram@lanecc.edu if you are not sure. Please provide name of institution and State. (e.g. Pioneer Pacific does not meet Northwest Commission of Colleges and Universities accreditation criteria).

Transfer coursework from Foreign Institutions

Must be evaluated by the application deadline by an outside credential evaluation service. The evaluation company must be either AACRAO Foreign Education Credential Service (www.aacrao.org) or a member of the National Association of Credential Evaluation Services (NACES). For a list of NACES memberships, please refer to their web site at www.naces.org. The evaluation must be a course-by-course detailed evaluation with an official copy submitted to Enrollment Services. The coursework must be considered to be at a post-secondary level, have comparable LANE accreditation status and be parallel in content to LANE coursework. The outside evaluation must also be completed for secondary level education for any evaluation of that coursework toward LANE admission requirements. APPLICATION POINT SYSTEM - Total points possible are 64 prior to the Interview Phase.

PER OCNE RULES, APPLICATION & INTERVIEW POINTS WILL NOT BE MADE AVAILABLE TO APPLICANTS. Eligible applicants will be assessed according to the following point system. The majority of this point system is uniform in all OCNE programs with each school having up to 17 discretionary points.

- 1. SECTION 3: Prerequisite GPA A maximum of 40 points will be awarded.

 The applicant must detail the meeting of these prerequisites on Form 2 Point Petition Sheet and submit official transcript(s) from accredited colleges or universities for all prerequisites. See Transcripts and Transfer Credits, Course Equivalency sections. Only the prerequisite courses will be counted in the application GPA.
- 2. SECTION 4: Oregon Consortium for Nursing Education (OCNE points) the agreed upon points for all institutions that are a part of OCNE as a community college of 4-year institution. Up to 11 points are possible.

Anatomy and Physiology courses:

- Completion of BI 231 and one additional Anatomy and Physiology course as listed in Item 1 is worth 3 points
- Completion of BI 231, 232 & 233 or equivalent course(s) as listed in Item 1 is worth 5 points OR

Sections 1 and 2 credits completed by the end of Fall term:

- Completion of 37 credits as listed in Form 2 from Sections 1 and 2 by the end of Fall term is worth 3 points OR
- Completion of 45-47 credits as listed in Form 2 from Sections 1 and 2 by the end of Fall term is worth 5 points

Prior Degree

Applicants who hold a prior degree and have the degree documented on their transcripts from an accredited institution will receive a maximum of 1 point. These are the OCNE standard points for prior degrees.

- Associate level degree or higher is worth 1 point.
- 3. SECTION 5: Lane Discretionary Points Each institution is allowed to use up to 17 points. Lane is using 4 points for the grade of A or B in Section 1 of Form 2. Therefore 13 points can be earned in Section 5.
 - 4 points Lane County residency for 90 days prior to applying, choose this link for a list of <u>acceptable towns</u> for a list of towns outside of Eugene/Springfield. CANDIDATE SELECTION - GROUP INTERVIEW PHASE – in addition to the 64 points from Form 2 another 30 points will be available from the Interview Scoring. Accepted and alternate students for Fall 2014 entry will be selected based on the highest points earned from Form 2 and the Interview Scores.

150% of available Fall 2014 nursing program positions (from the top qualified applicants – points from Form 2) will be invited to the interview. (e.g., 105 students will be invited to interviews if 70 students expected to be accepted into the program.) Interview questions in-person will be based on the subjects listed below. More details will be sent with the notification of an Interview Invitation. Students need to plan to be available and to be able to rearrange personal schedules to fit the date ranges listed on page 1.

Written and/or face to face Interview questions will be based on the areas listed below:

Diversity – The applicant expresses understanding, respect for and/or experience with varied backgrounds, cultures, ethnic groups, and lifestyles.

Personal Values – The applicant responds to written situations demonstrating integrity and values compatible with nursing core values and code of ethics.

Communication – The applicant conveys information, feelings, and opinions to others in writing. Written information is organized and clear with appropriate grammar and punctuation.

Motivational Fitness – The applicant identifies expectations about nursing role and responsibilities that are congruent with reality, demonstrates professionalism.

Tolerance for stress – The applicant describes strategies/behaviors that would enable maintaining stable performance under pressure.

Transferable skills – The applicant responds to situation questions in a manner that demonstrates problem solving, curiosity, leadership and critical thinking.

An established scoring criteria will be used that is used by other OCNE institutions Applicants will not have access to their interview scoring or evaluation scoring criteria afterwards per OCNE guidelines.

DEMANDS OF THE PROGRAM

It is important to understand the mental and physical demands of the nursing program and the career of the nurse. Applicants to the nursing program must be physically and mentally able to cope with the rigors of the curriculum and the demanding nature of the health professions. Nursing students must be able to grasp scientific concepts, set up and answer basic math and algebra problems, and communicate well verbally and in writing. Physically, students must be able to remain on their feet for extended periods, lift up to 25 pounds, hear heart and breath sounds, read fine print and identify skin tones such as pale, ashen, gray or bluish.

Established academic and clinical requirements essential to the program of instruction apply to all students and cannot be waived. Attempts will be made to accommodate and retain qualified applicants with disabilities unless results of evaluations indicate that given reasonable accommodation an individual will still be unable to perform the essential functions required by the program.

AMERICANS WITH DISABILITIES ACT

BSN DEGREE OPTION

Acceptance to the program allows for co-admission to Oregon Health & Science University (OHSU) Baccalaureate Nursing program. This allows Lane nursing students' eligibility to complete a BS degree in Nursing from OHSU without an additional competitive application process. Options available for Baccalaureate completion can be found at Oregon Health Sciences University.

NEW OHSU Requirement for Transition from Lane to OHSU.

From OHSU: "Students should understand that although co-admitted to the Oregon Health & Science University School of Nursing, those who choose to transition from the Lane Community College Nursing Program to OHSU will have to undergo a Criminal Background Check for OHSU at the <u>time of transition</u> and ability to enroll in OHSU courses may be negatively impacted by any criminal history in their background."

ADDITIONAL REQUIREMENTS, COURSES & COMPETENCIES FOR BS DEGREE:

- 1. Completion of additional courses including Statistics (MTH 243), Epidemiology, and 15 credits of upper division Humanities, Social or Natural Sciences.
- 2. Foreign Language Proficiency Language proficiency is a requirement for graduation with the bachelor's degree. This requirement can be met by:
 - a) Two years of the same high school language
 - b) A language proficiency examination
 - c) Two terms (quarters or semesters) of the same college level language. These credits could count toward the 45 prerequisite credits as well as the AAS and BS degree credits.
 - d) American Sign Language is an accepted language to meet the requirement.
