Learning Council Role in Degree Planning and Evaluation	• MyGradPlan & DegreeWorks are rolling out differently than expected and degree evaluators are communicating with departments about how to interact around getting a degree evaluation that present some problems. Enrollment Services directions are now messaging that the degree evaluation cannot happen until right before they are ready to graduate but this does not help students toward progression and completion.
