Each child care facility is required to create a written COVID-19 Health and Safety Plan to ensure safe operations and help reduce the transmission of COVID-19. The COVID-19 Health and Safety Plan developed for each child care facility should be tailored to each facility's unique needs and should be created in consultation with the Guidelines.

The Early Learning Division has developed a template you can use to create your safety plan. The plan must be provided to families in a manner they can understand by Friday, November 9, 2020. You do not need to send the plan to ELD unless requested...*Click here to keep reading.*

## **Distance Learning and DHS**

DHS recently shared information with providers about billing DHS for helping children with distance learning. Here is the guidance that was provided:



- If you are providing child care to students doing their schooling through distance learning, including remote, virtual or online school work, you can bill DHS.
- Families may also choose to use child care if their child is not going to in-person schooling due to COVID-19 medical or health reasons.
- As a provider, you can bill DHS for helping children with distance learning. For example, you may
  help a child log in online, contact a teacher, develop schedules to support a child's distance
  learning and assist with completion of school work. You may not bill when you provide educational
  services, such as tutoring or instruction or for the cost of tuition; you may only bill for hours of child
  care provided.
- If you choose to increase your rates based on providing educational instruction, you will need to

bill the family who would be responsible for that cost.
